


• KEYNOTES

- RE-CONTOUR SITE TO PRE CONSTRUCTION GRADE. FINISHED GRADE WILL BE IRREGULAR WITH GOAL OF APPROXIMATING NEARBY LAVA FLOW TOPOGRAPHY AND APPEARANCE. FINISH SURFACE TO MATCH ADJACENT EXISTING UNDISTURBED LAVA FLOW AREAS IN APPEARANCE SATISFACTORY TO OWNER.
- DIRT ROAD (OLD MAUNA KEA ACCESS ROAD) TO REMAIN (NOT FOR USE DURING CONSTRUCTION).
- DEMOLISHED EXISTING STRUCTURE, SHOWN FOR REFERENCE.

 (ESTIMATED FILL = 279 CU.YD.) SEE ARCHITECTURAL DEMOLITION PLAN SHEET AS101.
- 4. LOCATION OF TEMPORARY CONSTRUCTION FENCE. SEE ARCHITECTURAL.
- 5. EXISTING UTILITIES TO REMAIN. REFER TO AS101.
- 6. BOULDER GROUP AREA, TO BE REMOVED AND RELOCATED TO ADJACENT BATCH PLANT SITE.



- 3. A MINIMUM OF FIVE CUBIC YARDS OF SOIL TO BE REMOVED, AND SHALL BE SEGREGATED AND SCREENED USING A SCREEN SIFTER WITH 1/2" SQUARE HOLE
- 4. NO FILL OR AGGREGATE MATERIAL IS TO BE IMPORTED. FILL MATERIAL FOR NEW GRADES IS TO BE TAKEN FROM CUT MATERIAL ON SITE.
- 5. SEE CS102 FOR LOCATION TO STOCKPILE REMOVED SOIL.
- 6. CONTRACTOR TO PROVIDE FINAL SURVEY IN ELECTRONIC FORMAT ONCE REGRADING IS COMPLETED.
